  increased due to Kristi Calder's contract, summer student and Deanne was hired as an
  admin.
- Lower Columbia Regional Project to develop the Lower Columbia as a tourist
  destination. Funding comes from DBT, TR, DBC & Cost Sharing partners. Development of
  a photo and video bank, support regional events, create a regional event calendar,
  website (landing page to re-direct visitors), development of the Kootenay Golf and
  Adventure Trail.
